**Scheduled Election**

*Fair Work (Registered Organisations) Act 2009*

**Nominations**, which must be in writing and comply with the registered rules of the Organisation, may be made at any time from Wednesday 16/04/2025.

A nomination form must then be lodged in accordance with the Organisation's rules.

Additional forms are available from the Returning Officer.

*Prospective candidates and nominators **should verify their financial status and any other qualifications required by the Organisation's rules** prior to lodging nominations.*

A member of the Electoral College **may be nominated for more than one position** on the Branch Committee of Management **in the one election but may not hold more than one such position at a time.**

*Of the **President and two Senior Vice-Presidents** offices, one shall be from the members of the Branch Electoral College attached to the Northern Territory Division and two shall be from the members of the Branch Electoral College attached to the Queensland Division.*

If a member attached to the Northern Territory Division is elected to the position of President, *any nomination for Senior Vice-President by a member attached to the Northern Territory Division will lapse.*

If members attached to the Queensland Division are elected to the position of President and to a Senior Vice President position, *all other nominations for Senior Vice President from members attached to the Queensland Division will lapse.*

Nominations **must reach** the Returning Officer via the lodgement method(s) stipulated below **not later than** 12 noon Australian Eastern Standard Time (AEST) **on** Wednesday 30/04/2025.

**How to lodge nominations**, nominations must be lodged via the following method(s):

**By Email:** A properly completed nomination form including all necessary signatures and attachments may be scanned and submitted as a **PDF** file to [iebnominations@aec.gov.au](mailto:ieb nominations@aec.gov.au)  
The subject line of your email should include the reference: **“E2024/207 - Stage 2 Nomination & [your name]”**

**PLEASE NOTE:**

1. Emails to the AEC inbox that appear to be spam may be blocked. ***It is the responsibility of senders to ensure that their email reaches the AEC before the deadline for nominations.***
2. In order to be able to be received by the AEC, emails (including attachments) should be no greater than 6 MB in size.
3. You may call 03 9285 7111 to enquire about the status of your nomination.

**Withdrawing Nominations**

Nominations cannot be withdrawn.

**Voting Period**

The ballot, *if required*, will open on Wednesday 14/05/2025 and close at 10am Australian Eastern Standard Time (AEST) on Wednesday 11/06/2025. A postal vote pack will be mailed to eligible voters on Wednesday 14/05/2025.

**Replacement Voter Pack**

If you are on the roll of voters, a replacement ballot pack will be sent by regular mail.

A form is available from the Returning Officer for the purposes of appointing Scrutineers.
